Planning for NASCSA for 2011 began just hours after the Executive Committee was installed on the last day of the 2010 conference. Each year at the end of a conference, it seems that the general feeling of the Committee is that there are only 362 days left until the next conference! While that may seem like a long time, it takes an extraordinary level of commitment and coordination to achieve the goals the organization sets for itself each year.

While the Executive Committee sets the course, the work to get there is mainly accomplished through six subcommittees: Bylaws/Resolutions; Membership; Policies/Procedures; Program; Special Projects and Survey/Data. Each subcommittee consists of regular and associate members and is chaired by a member of the Executive Committee. Much of the work is "data-driven", based on feedback at the conferences and other communications. One telltale of the success of this approach was the record number of resolutions on topical issues adopted by the membership at the recent conference.

The resolutions had been largely based on issue areas identified in evaluations of the 2009 conference. Thus, the feedback that members provide in conference evaluations is used well beyond planning for the next conference. It is the participatory nature of the organization that enables it to accomplish so much in so little time.

On March 1, 2011 the US Drug Enforcement Administration issued a final order to temporarily place five synthetic cannabinoids chemicals (JWH-018, JWH-073, JWH-200, CP-47,497, and cannabicyclohexanol) used to make "fake pot" products as a Schedule I controlled substance. State Regulatory Developments

State Regulatory Developments is a monthly compilation by NASCSA of state regulatory actions related to pharmacy and controlled substances. State Regulatory Developments is located on the website www.nascsa.org under "News."

Monitoring Program (PDMP) Grant Program have been announced. The grant program is funded by a \$200,000 grant from Purdue Pharma, LP to support the operation, expansion and awareness of appropriately-designed state prescription drug monitoring programs.

NASCSA's Special Projects Committee, consisting of Ralph Orr (VA), Danna Droz (OH) and Mark Keeley (OH), were responsible for evaluating the proposals and making recommendations to the Executive Committee who recently approved the recommendation.

Below is a description of the PDMP projects funded through the grant program:

- Florida - Marketing and education plan for implementation of the PDMP;
- Indiana - Prescription mapping and information exchange network and RX Watch: Web application to allow certain users access to view de-identified and demographic data in possession of the program;
- Kansas - An initiation evaluation of perceptions related to prescription drug abuse, diversion and pain management in Kansas;
- Maine - Evaluation of risk factor identification for prescription drug overdose using PDMP and Medical Examiner case data;
- Michigan - Automation of processes to distribute notification letters to physicians to alert them of possible abuse/diversion by their patients;
- Minnesota - Provide for software update for management of passwords and education/marketing campaign;
- Mississippi - Marketing and education plan for the PDMP;
- Virginia - Sponsor educational conference and produce education/marketing materials;
- Washington - Provide IT Quality Assurance Services or marketing of the program; and
- Wyoming - Provide education and marketing about the program.

NASCSA Participates at NABP Task Force Meeting on PDMP's

Ralph Orr, VA recently represented NASCSA before a task force convened by the National Association of Boards of Pharmacy (NABP) to discuss state Prescription Drug Monitoring Programs (PDMP's). NABP convened a meeting of the Task Force on Prescription Monitoring Program Standards in late October in Northbrook, IL. The Task Force has been charged with reviewing and identifying variations in existing prescription monitoring programs as compared to the *Model Prescription Monitoring Act* found in the *Model State Pharmacy Act and Model Rules of the National Association of Boards of Pharmacy (Model Act)*; and potentially recommend revisions, if necessary, to the NABP *Model Act* addressing this issue. Additional details will be made available upon publication by NABP.

NASCSA Testifies at DEA Hearing on Drug Disposal



Ralph Orr, Secretary/Treasurer of NASCSA attended a public meeting conducted by the DEA on January 19-20, 2011 in Washington, D.C. The purpose of the meeting was to hear comments about procedures for the surrender of unwanted controlled substances by the ultimate user to assist

DEA in developing regulations to implement the Secure and Responsible Drug Disposal Act of 2010. There was a great deal of consensus on many facets of the issues to include the following:

- The need for a range of options for secure disposal of controlled substances and other pharmaceutical drugs-convenience and accessibility is essential;
- Take-back programs should be able to include both controlled and non-controlled substances without sorting them;
- Security of the medications to be disposed of is critical, including tracking of containers, tamper evident seals, locked containers, and other such measures;
- Regulations should not require that individual pills/vials/etc. be counted and logged. Many presenters suggested logging by weight;
- Allow different means of destruction of collected meds while contemplating hazard requirements; and
- Cost to consumers and states must be considered

Mr. Orr presented information at the meeting based specifically on the 2007 and 2010 NASCSA resolutions pertaining to drug disposal and take back programs, which are found at www.nascsa.org. A copy of NASCSA's formal testimony is found [here](#).

Oklahoma- The Oklahoma Board of Pharmacy has teamed with the nonprofit Oklahoma Pharmacy Educational Foundation and the local chapter of the National Association of Drug Diversion
